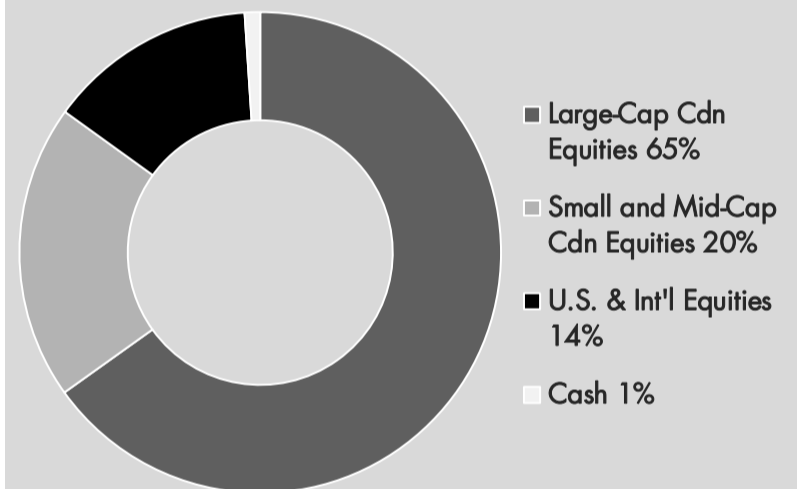
Fund Objectives

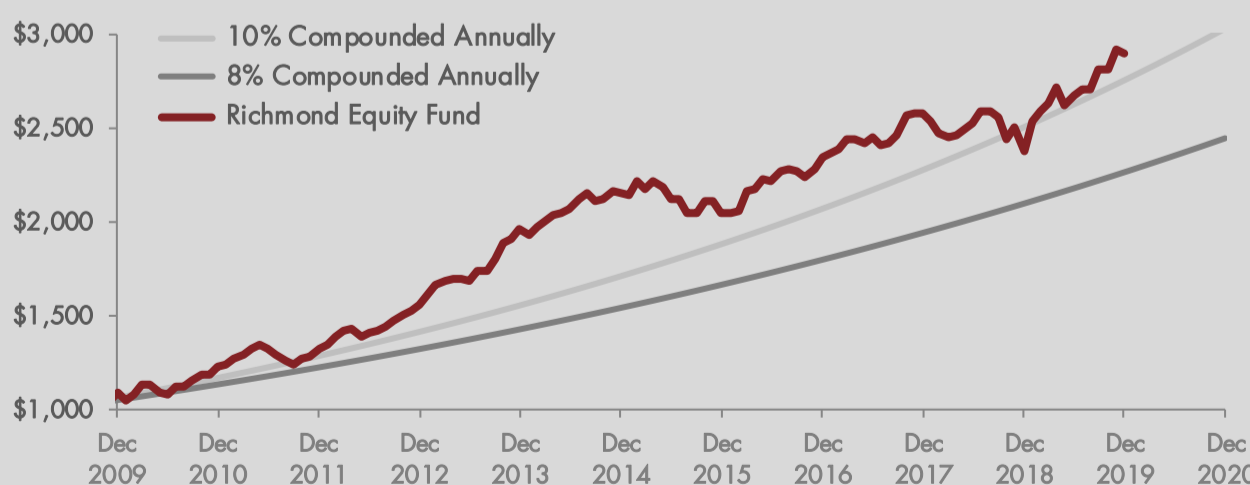
